Rent Collection/Credit Control

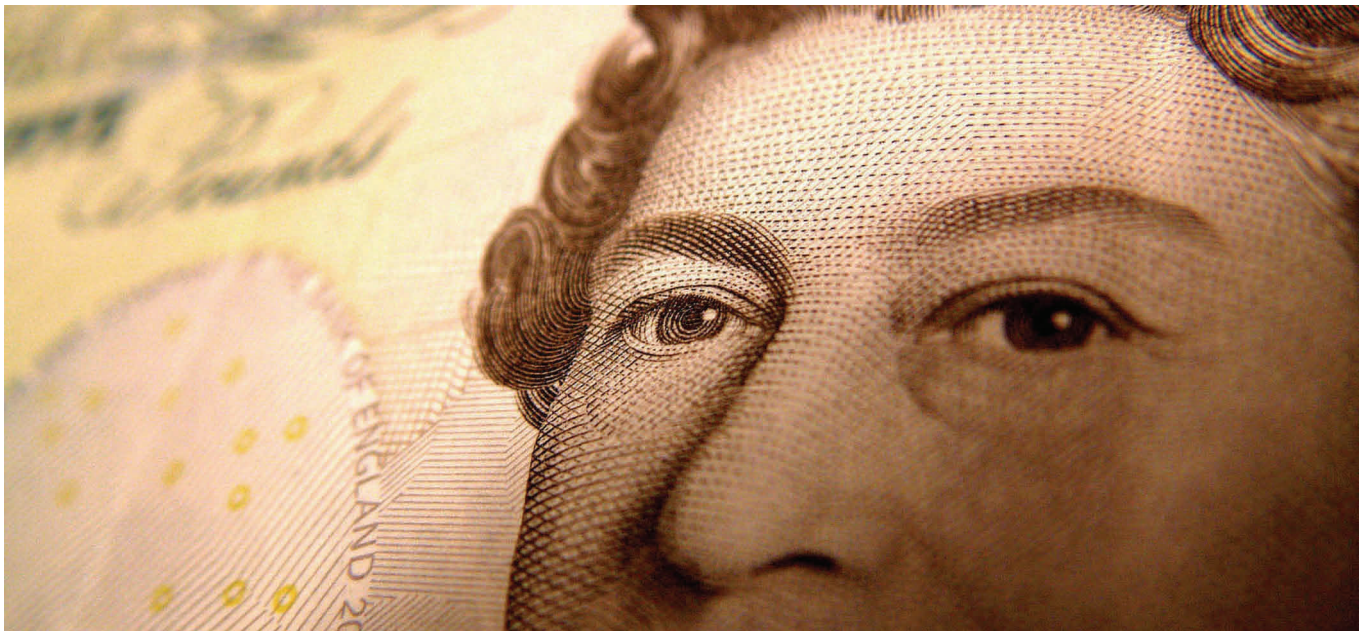
