Property Description

Set in a spectacular elevated position on the Ardnamurchan Peninsula, the Land at Laga Farm presents a rare opportunity to purchase one of two superb development sites, each accompanied by its own parcel of hill land. This natural environment includes open hill ground, fenced native woodland, and prepared development platforms suitable for residential development.

House Site 2 (within Land Area B) previously held planning permission in principle for a single residential dwelling, and it is expected that any offers will be subject to reinstatement of this consent.

The extensive landholding offers excellent potential for woodland planting and open hill deer stalking, while the established native woodland provides scenic walking opportunities. Both parcels sit within a National Scenic Area and form part of the Sunart Oakwood and National Rainforest, making them highly suitable for rewilding or long term conservation projects.

Mains electricity and private water supplies are located nearby for connection, and the site has already been levelled in readiness for development. A formed access track leads directly from the public road.

Both sites command exceptional views over Loch Sunart and the dramatic surrounding landscape—an idyllic setting for buyers seeking peace, seclusion, and a close relationship with nature.

The area is renowned for its abundant wildlife, including red deer, golden eagles, and otters, making it ideal for outdoor enthusiasts and conservation-minded purchasers.

Despite its rural tranquillity, the location benefits from convenient access to local amenities and attractions. The Ardnamurchan Peninsula is celebrated for its pristine beaches, scenic walking routes, and strong community spirit, while still offering exceptional privacy.

This is a rare chance to enjoy the charm of remote Highland living combined with the potential for bespoke residential development in one of Scotland's most beautiful regions.

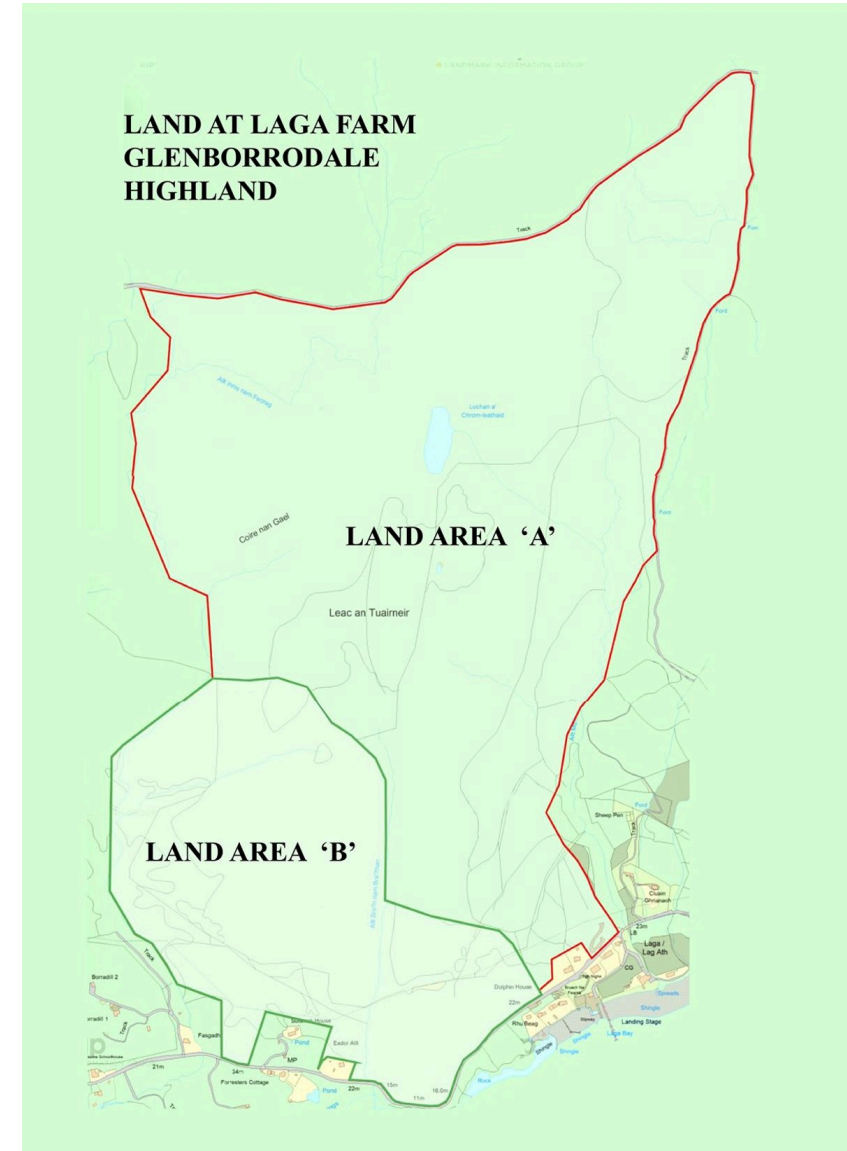
